KEEPING THE PEACE

With the community growing, we wanted to take a moment to assist residents in the understanding of the Enforcement Policies within the Master Association. Living in an association can offer many advantages to its Members. In order to protect and preserve these benefits, certain limitations and restrictions are placed on the Members in accordance with the CC&R's for the community. Many times these restrictions are viewable by management and the Board of Directors during inspections, such as yard maintenance, trash cans being left out or general maintenance of the home. However, there are times that violations of the CC&R's cannot be viewed, such as noise complaints from barking dogs or surrounding residents. In order to ensure fair enforcement of these types of issues, the Association has an adopted Enforcement Policy, which states that complaints for items that cannot be viewed during inspections must be submitted in writing and must be received by two separate property owners.

Alleged violations that fall under Section Article VIII, Section 7 "Quiet Enjoyment" of the CC&R's will be reviewed by the Board of Directors once the requirements of the Violation Enforcement policy have been met. Once this has occurred, the Board evaluates these types of complaints in accordance with the Association's CC&R's and looks for guidance to ordinances set forth by the city or appropriate governing agencies, depending on the issue. For example, noise complaints such as noise from back yard water features would be reviewed in accordance with the noise ordinance adopted by the city. Noxious odors may be reviewed in accordance with guidelines set forth by the Board of Health, etc. All cases of this nature are reviewed on a case by case basis and will be carefully thought through by the Board prior to enforcement. Should you have questions on this matter, or have a specific issue you would like the Board to address, please feel free to contact management for assistance. MAIL THEFT AND HOW WE CAN PROTECT OURSELVES

Unfortunately mail and package theft has become an issue in the Orange County area, especially in the nicer areas such as Woodbury. Management works closely with Irvine PD in monitoring the neighborhood, but it only takes a brief moment for a thief to grab a package from a door step or take someone's mail, making it a difficult matter to regulate. In an effort to keep our residents informed we are offering the following suggestions, provided by the Irvine Police Department, in response to recent mail thefts.

- Always deposit your mail inside your local post office, or hand it to your letter carrier.
- Have your local post office hold your mail while you're on vacation, or absent from your home for a long period of time.
- If you don't receive a check or other valuable mail you're expecting, contact the issuing agency immediately.
- Check your incoming mail as close to your delivery time as possible.
- If a package is being delivered without a signature required, make sure someone will be home to receive the package.

Although most of the mailboxes in Woodbury are maintained by the Association and cannot be altered, there are locking mailbox inserts that can be purchased online, which can easily be installed inside your mailbox for your protection. These products can be purchased online or through mailbox retailers. Please note if you do choose to purchase an insert, you would be responsible for its maintenance, any damage to the mailbox structure and for providing any new owner of your home the keys.

If you observe what appears to be a theft in progress immediately call Irvine PD dispatch at (949)724-7200.

STREET PARKING IN WOODBURY

As you may or may not be aware, most streets in Woodbury are maintained by The City of Irvine and parking enforcement is done by Irvine PD. If you note a stored vehicle on a street, you may contact Irvine PD at (949) 724-7200 to tag the vehicle for storage and possible removal. If the street is private, they will direct you to the association. Because of the growth in the community, many of the streets are becoming congested with vehicles. As a reminder, your garage is meant to park vehicles not for storage. Help us keep our streets open and safe by parking in your garage. If you note a garage storage issue and live in a sub association, please contact that managing agent to assist you with the enforcement policies for that association. If you live in the single family homes and have an issue on your street, the Master Association is governed by the Neighbor to Neighbor Dispute policy, in which complaints must be submitted in writing by two separate Owners. You may have noticed over the past couple of months, repairs that have taken place at the Commons pool areas. Although we are almost finished with these repairs, the Lagoon Pool spray garden will continue to be closed while some of the parts were shipped out for warranty replacement. We anticipate this area to be open in the spring for your enjoyment. In the fall, Promenade Square and Cypress Square pool will be closed for resurfacing after November 1st. But all pools should be opened and heated as of April 1st for community use. We understand the closure of these pools may sometimes be an inconvenience and appreciate your patience.
