LETTERS FROM THE ASSOCIATION:

Management will conduct weekly property inspections, and while onsite we will generate letters to homeowners for violations we notice. These letters may require you to repaint areas on your property or correct a CC&R violation. Here are some helpful tips in dealing with these friendly reminders.



- Don't get upset. No one likes to receive these letters, but remember a courtesy letter is just that, a courtesy. From time to time, a friendly reminder is sent to you letting you know that an item needs to be addressed.
- Correct violations before they happen. Put away your trash can or mow your lawn weekly. Keep your neighborhood looking good. This helps protect your property values.
- Don't ignore the Association's request. Homeowners are sent a courtesy note, if the violation continues, then a first letter giving a time frame to correct the violation is sent. If a homeowner still does not correct the violation, they will be called to a hearing before the Board. Correct violations immediately and/or call your Manager to discuss.

COMMON VIOLATIONS TO AVOID:

- No contractor signs are allowed anywhere in the community.
- If you are selling or leasing your property, specific signage is required; see the Rules and Regulations or "Policies" on the Woodbury website for details.
- Failure to submit for architectural approval prior to installation of your landscaping can result in a fine.
- If you do not live in the community, please be sure that we have an active mailing address for you. We send important notices that, if remain ignored, can result in costly fines.
- Please be mindful that trashcans must be stored out of common view, unless it is 12 hours before and after trash pickup day.



OPENING OF THE AMENITIES UPDATE:

All of the pools in the Woodbury Community are open for use by reservation! Beginning October 5th, residents can make 1 hour and 15-minute reservations at all of the pool locations. Please remember to bring your key card to get in, as there will be no pool monitor. The tennis courts, basketball courts, and volleyball court are open. 





Woodbury residents can safely and securely dispose of up to five banker-size boxes (24 inches x 12 inches) at a mobile shredding unit on-site in the Woodbury parking lot at 108 Lamplighter. This event will be held on Saturday, November 7th from 8 a.m. to 11 a.m. Event ends once truck capacity has been reached. Please ensure all provided documents and boxes are free of binders, paper clips, plastic sleeves, and metal butterfly clips. Items not accepted include: CD's, credit cards, three-ringed binders, wire dividers, newspapers and magazines, and spiral notebooks. Must show your Woodbury key card as proof of residency.

NEW CLUSTER MAILBOX UNITS:

Due to the increase in mailbox theft in the single-family homes that have the curbside mailboxes, the Board of Directors approved to have cluster mailbox units installed. Certain streets have already been completed and the rest of the single-family homes will be done in phases. Please keep an eye out for a letter from the Association that will indicate when you can pick up your new mailbox keys. Please note that the post office representative took in to consideration the location of where the cluster units will be installed by making sure none were in front of any homes.

Please keep in mind that if the boxes are not right by your house, that the reason the boxes are the way they are is to keep streets together. When routes are designed, the post office tries to keep one carrier in a certain area, depending on the routes, line of travel and the amount of deliveries so they don't have to break certain tracks between two routes.

Please make sure to pick up your new mailbox keys so you can pick up your mail when the curbside boxes are removed.

TRICK OR TREATING MEASURES THAT CAN HELP PREVENT ACCIDENTS:

- A child can wear a light-colored costume or one with reflecting tape sewn on so they can be easily seen by drivers.
- The costume should be made of a material that does not burn easily.
- Because masks can block vision, many parents of small children should use face makeup instead.
- Children should visit only homes in their own neighborhood.
- Younger trick-or-treaters should be accompanied by an adult.



BLOCKING MAILBOXES:

Please refrain from parking in front of or blocking the mailboxes. The USPS has placed reminders on many mailboxes within the community asking residents to not park in front of mailboxes, as it restricts the mail delivery and access to get your mail.

IF YOU RENT YOUR HOME - WHAT YOU NEED TO KNOW:

You are responsible for your tenants!

- This means you need to provide them with and make sure they are aware that there are Rules and Regulations & CC&R's.
- If they are violating any of the CC&R's or Rules and Regulations, you will receive a violation letter and your tenant will be mailed a copy. If the violation is escalated to a hearing, you will be asked to attend the hearing to discuss the issue with the Board of Directors.

You automatically delegate the use of the recreational amenities to your tenants for the duration of their tenancy and your rights to use and enjoy the Master Association Property, and the recreational amenities are suspended. This means that you will not have access to use the pools/basketball courts/tennis courts or be able to reserve the clubhouse for an event or attend the Community events. (see Section 4 of the CC&R's)
